- Green energy providers – We will review our energy providers and see if we can choose green options to reduce our carbon footprint
- Carbon Offset Scheme – Review schemes available to offset the small of emissions we do produce
- International travel review – As our business is growing and we are expanding in locations we will continue only essential travel is taken.
